User management

- There are two user categories: superusers, who are granted more extensive authorisations, and standard users. One or more superusers can be defined at the customer's request.
- Superusers can create new users and edit existing ones, as well as granting or removing write/read access rights for individual apps and policies. It is also possible to adapt authorisations for specific specialist areas such as submitting limit applications or reporting claims.
- The 'user management' app is only visible for superusers.

Declaration of Outstandings and Turnover

- Information that forms the basis for the monthly premium calculation can be easily reported online.
- · Clear layout: The app displays which reports are currently pending, grouped by contract and category.

Limit

- Search for partners in the comprehensive ACREDIA databases.
- · Submit credit limit applications conveniently online.
- Manage credit limits and partner data easily and conveniently.
